We the People High School is committed to ensuring meaningful stakeholder engagement to develop all local plans. WTP used a variety of strategies in the Spring of 2021 and the Fall of 2021 to gather stakeholder input including surveys, online and in-person meetings, Board meetings, and teacher professional development. We the People High School’s Parent Organizing Committee (POC) is the parent governance arm of the LEA. The schedule for monthly POC meetings is developed in the spring of each school year with the input of parents. Meeting dates and location(s) are distributed to all parents in multiple languages at the start of each school year. Parents also receive bi-monthly electronic newsletters, monthly mailings, and weekly text via our multilingual two-way texting system. The public at large is welcome to attend our monthly Board of Director meetings to provide input on agenda items. Stakeholder engagement related to the development of this specific plan took place at the following:

- Board Meeting presentation on October 25, 2021.
- Parent outreach via newsletters and email in late October; November 2021 Parent Meeting.

- Student government meetings in October 2021.
- Weekly professional development with staff in October 2021.

We the People High School does not serve members of Native Tribes in the region, migratory students, or children who are incarcerated. We the People does serve English learners, homeless and foster youth, and other underserved students. We the People High School consulted with key community stakeholders, including board members and parents, who serve or who are guardians to these populations of students. In addition, We the People High School administration and staff consults with the wraparound teams for homeless and foster youth to determine ongoing needs and supports.

From our discussions with our stakeholder community over the summer (as new students enrolled) and during the fall meetings mentioned above, it became clear that students would need tutoring and extra academic support from qualified staff, and that the cleanliness of our facility was necessary to maintain the health and safety of all students for in-person learning. In particular, parents of rising 9th graders requested extra support for students who did not do well during 1.5 years of distance learning and had pronounced academic gaps as a result.

ESSER III Expenditure Plan Instructions

Introduction

School districts, county offices of education (COEs), or charter schools, collectively known as local educational agencies (LEAs), that receive Elementary and Secondary School Emergency Relief (ESSER) funds under the American Rescue Plan (ARP) Act, referred to as ESSER III funds, are required to develop a plan for how they will use ESSER III funds to, at a minimum, address students' academic, social, emotional, and mental health needs, as well as the opportunity gaps that existed before, and were exacerbated by, the COVID-19 pandemic.

The plan must be adopted by the local governing board or body of the LEA at a public meeting on or before October 29, 2021 and must be submitted for review and approval within five days of adoption. A school district must submit its ESSER III Expenditure Plan to its COE for review and approval; a COE must submit its plan to the California Department of Education for review and approval. A charter school must submit its plan to its chartering authority for review and to the COE of the county in which the charter school operates for review and approval.

- Written in an understandable and uniform format;
- Written in a language that parents can understand, to the extent practicable;
 - If it is not practicable to provide written translations to a parent with limited English proficiency, the plan must be orally translated for parents
- Provided in an alternative format to a parent who is an individual with a disability as defined by the Americans with Disabilities Act, upon request; and
- Be made publicly available on the LEA's website.

Ensuring Interventions are Addressing Student Needs

The LEA is required to ensure its interventions will respond to the academic, social, emotional, and mental health needs of all students, and particularly those students most impacted by the COVID–19 pandemic, including students from low-income families, students of color, English learners, children with disabilities, students experiencing homelessness, children in foster care, and migratory students.
